SUMMARY ANNUAL REPORT

FOR NORTHWEST ROOFERS & EMPLOYERS HEALTH & SECURITY PLAN

This is a summary of the annual report for the Northwest Roofers & Employers Health & Security Plan, (Employer Identification No. 91-6030802, Plan No. 501) for the period April 1, 2018 to March 31, 2019. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Basic Financial Statement

The value of plan assets, after subtracting liabilities of the plan, was \$10,186,499 as of March 31, 2019 compared to \$6,987,291 as of April 1, 2018. During the plan year, the plan experienced an increase in its assets of \$3,199,208. This increase includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year, or the cost of assets acquired during the year. During the plan year, the plan had a total income of \$10,700,203. This income included employer contributions of \$10,102,672, employee contributions of \$60,960, realized losses of (\$10,247) from the sale of assets and earnings from investments of \$497,494.

Plan expenses were \$7,500,995. These expenses included \$782,366 in administrative expenses and \$6,718,629 in benefits paid to participants and beneficiaries.
